CMA MUSIC FESTIVAL STRIKES UP THE BAND TO "KEEP THE MUSIC PLAYING" FOR METRO NASHVILLE PUBLIC SCHOOL STUDENTS

NASHVILLE - Nashville Mayor **Karl Dean**, BNA Records star **Kellie Pickler** and Country Music Association Chief Executive Officer **Tammy Genovese** were at Thurgood Marshall Middle School on May 8<sup>th</sup> for a special delivery. A truckload of musical instruments and equipment were delivered to the students courtesy of "Keep the Music Playing" and CMA Music Festival.

"We are thrilled to be making this delivery today," said Genovese. "Due to the generosity of the artists who donate their time to perform for free at CMA Music Festival, we are able to supply not only Thurgood Marshall, but 29 other schools in the Metro Nashville public schools system with the musical equipment they desperately need."

"The Keep the Music Playing program is an example of the community involvement needed to improve our schools," said Mayor Dean. "Through this donation, CMA is bringing music education into our classrooms and making a difference in the lives of our students and, in turn, the future of our city."

"Music is so dear to my heart," said Pickler.
"I think it's great that these kids are able to

get involved in music at a young age. It's an outlet to get away from your normal class schedules, it's a challenge, and it's a positive thing for kids to get involved in."

CMA Music Festival contributes half the net proceeds from the annual four-day event to music education for Metro Nashville's 75,000 public school students through a partnership with the Nashville Alliance for Public Education called "Keep the Music Playing." To date, CMA has donated more than \$1.1 million to purchase hundreds of instruments, lighting and sound equipment, piano labs and more on behalf of the artists who donate their time and perform for free at the annual Festival. The instruments donated this year were purchased with a gift of \$655,624 from proceeds of the 2007 CMA Music Festival.

CMA Music Festival is Nashville's signature musical event celebrating America's music. The event brings together not only people in Middle Tennessee, but also fans from all over the world. With record setting attendance in 2007 of 191,000 over four days, CMA anticipates being able to contribute even more to the Nashville Alliance for Public Education to be used for school music programs in the future.

Now in its 37th year, the 2008 CMA Music Festival will be held on Thursday through Sunday, June 5-8 in downtown Nashville. Dubbed the "crown jewel of Country Music Festivals" by *USA Today* and winner of the

International Entertainment Buyers Association's 2006 LIVE! Award for Festival of the Year, the event features four days packed with music, autograph signings, family activities, sporting competitions, and much more.

# INTERNATIONAL ASSOCIATION OF JAZZ EDUCATORS FILES FOR CHAPTER 7 BANKRUPTCY

The world of jazz education is mourning the loss of the one organization that was dedicated to this specific field of music as the IAJE (International Assn. of Jazz Educators) has officially closed its doors. According to a letter from Chuck Owen, the President of IAJE on Friday, April 18, "the board voted to file for bankruptcy under Chapter 7 of the Federal Bankruptcy Law." This leading music education association, which had over 8,000 members, an international convention, a bi-monthly journal, and a history of over 40 years has been crushed under a mountain of debt, according to an article in the Seattle Times, April 18, 2008. The *Times* article indicated that the organization is rumored to have been over \$1 million in debt, according to Greg Yasinitzy, an IAJE division coordinator. It is difficult to pinpoint the exact reasons for this unprecedented downfall, but there were obviously festering financial difficulties which were not specifically addressed by either the paid management team or the elected board.

According to the Web site Guidestar.org, which provides information for charitable

organizations, IAJE's 2005-2006 tax return indicated a negative asset value of approximately \$90,000. The timeline regarding the financial difficulties is unclear from this point on, as this was the last publicly available statement filed with Guidestar.org. Indications suggest that due to a combination of poorly attended conventions, escalating costs of publications, and other increasing expenses, the group continued to lose money until there was no further way to control the debt load. According to Owen's letter, there was a late effort made by the board to raise funds to alleviate the financial problems, but this fell far short of raising the necessary funds. It's difficult to understand how the debt levels were allowed to increase so dramatically from '05-'06 to the present without steps being taken earlier in time in order to reverse the cash outflow and perhaps save this venerable Association.

In the field of music education, there are many well-run associations that are an integral part of many music educators' career enhancement and training... The lectures, performances, networking opportunities and trade shows that organizations provide offer a wealth of benefits for serious educators. The loss of the IAJE is not only a powerful blow to the 8,000 members who invested their time and money into supporting the association, but also to the greater music education community which benefited indirectly from the efforts of this group.

As IAJE's Chuck Owen noted, "Our efforts and our passion should be to collectively rally the community to recognize the importance IAJE has had and continues to have in the life and development of jazz and jazz education - seeking new strategic partnerships, new government structures, and a revitalized mission that embraces

current needs... Mary Jo Papich, who would have begun serving her term as President of IAJE beginning this July, is dedicated to recreating such an association. As many know, Mary Jo has been a tireless advocate for IAJE, serving it long and well. You will undoubtedly be hearing from her in the near future. When she does contact you, I urge you to join me in offering her every support and assistance. Of course others may also seek to fill this void by promoting alternative visions for empowering, serving, and gathering the jazz community. While I generally believe such diversity is quite healthy, I would strongly encourage all such efforts and leaders to attempt to collaborate and seek ways to unite us in spirit and strength."

### PHIL RAMONE PRIMED TO BRING PERFECTION TO 2008 SONGWRITERS HALL OF FAME INDUCTION CEREMONY JUNE 19

### John Legend, Lee Ann Womack, Natasha Bedingfield and Blake Shelton Scheduled to Perform

"Recording-studio genius" (Hollywood Reporter) Phil Ramone gears up for another star studded evening of exciting musical pairings for the 2008 Songwriters Hall of Fame Induction Ceremony June 19<sup>th</sup> at the Marriott Marquis Hotel in New York. This year's inductees are Desmond Child, Albert Hammond, Loretta Lynn, Alan Menken and

John Sebastian. John Rzeznik of the Goo Goo Dolls will receive the Hal David Starlight Award, Paul Anka will receive the Johnny Mercer Award, and Anne Murray will receive the Hitmaker Award.

Confirmed performers for this year's ceremony include Lee Ann Womack, Blake Shelton and Natasha Bedingfield. John Legend is also scheduled to honor Paul Anka with a special performance during the show.

### SNAAP: NEW NATIONAL PROJECT TO EXAMINE IMPACT OF ARTS TRAINING

The Strategic National Arts Alumni Project (SNAAP) was launched today to examine the impact of arts training. It will provide a first-ever in-depth look at the factors that help or hinder the careers of graduates of arts high schools, arts colleges and conservatories, and arts schools and departments within universities, whether the alumni work as artists or pursue other paths.

Arts alumni who graduated 5, 10, 15 and 20 years earlier will provide information about their formal arts training. They will report the nature of their current arts involvement, reflect on the relevance of arts training to their work and further education, and describe turning points, obstacles, and key relationships and opportunities that influenced their lives and careers.

The results of the annual online survey and data analysis system will help schools

strengthen their programs of study by tracking what young artists need to advance in their fields. In addition, the information will allow institutions to compare their performance against other schools in order to identify areas where improvements are needed. "SNAAP will allow arts education institutions to assess their effectiveness and help them better prepare their students for the careers they enter - in the arts or not," says Mary Schmidt Campbell, Dean, Tisch School of the Arts, New York University.

The Indiana University Center for Postsecondary Research will administer the annual survey in cooperation with the Curb Center for Art, Enterprise and Public Policy at Vanderbilt University. Steven J. Tepper, Curb Center associate director, says "SNAAP is a milestone for cultural policy research, because it will go beyond profiles of individual artists and provide a comprehensive look at the creative workforce in America and the critical role of training institutions in preparing artists and creative workers." The project will be guided by a National Advisory Board comprised of leaders from all types and levels of arts training institutions, visual and performing artists, and arts and community development leaders from the nonprofit and commercial sectors.

Artists often don't work in the exact fields in which they trained. Instead, they may work at the boundaries between disciplines. They frequently move between the nonprofit and commercial sectors and hold multiple jobs. Moreover, there is a growing demand for arts training, both from students and the rising number of employers in the creative economy. Arts-training institutions and civic policy makers need good data to respond and plan effectively. "More than any arts education project in the past few decades, SNAAP has the potential to guide

needed change in the curriculum," says James Undercofler, President and CEO of the Philadelphia Orchestra.

Over time, SNAAP findings will allow institutions to learn more about the impact of their educational programs to better understand, for example, how students in different majors use their arts training in their careers and other aspects of their lives. Policy makers and community leaders will be able to use SNAAP findings to understand local, regional, and national arts workforce issues and market patterns. The results will also indicate how students who have trained intensively in the arts contribute to their communities and different areas of the economy.

According to George Kuh, Indiana University professor and SNAAP project director, the arts alumni survey will be extensively field-tested in 2008 and 2009 with as many as 100 institutions before its first national administration in 2010. "We'll learn a lot about what matters in arts training from these early results and also be able to fine-tune the survey for future use," stated Kuh. The Vanderbilt University Curb Center will host a national conference in 2010 to explore the educational and cultural policy implications of SNAAP findings.

After several years of studying the need for and feasibility of the project, the Surdna Foundation recently awarded a five-year \$2,500,000 leadership grant to help launch the project. Phillip Henderson, Surdna Foundation President, believes that SNAAP will be "one of the signature accomplishments of our foundation in this decade, and its value to arts training institutions will only increase over time."

"For the first time, SNAAP results will allow us to see how high-quality, deep

training in the arts guides professional careers of creative American citizens," says Sarah Bainter Cunningham, Arts Education Director at the National Endowment for the Arts.

In addition to Surdna and the National Endowment for the Arts, support from other funders is anticipated to support the testing phases of the project and insure widespread participation. SNAAP is expected to become self-sustaining through institutional participation fees by 2012.

"NAMM has conducted research that found 82 percent of people who have never played an instrument wished they had," said Joe Lamond, president and CEO, NAMM. "This is our way of helping people to discover their inner musician, find their own rhythm and start to reap all the proven benefits that come along with playing."

For many years, NAMM has funded research showing that playing music provides a variety of positive benefits, ranging from increased intelligence to healthier lifestyles. Studies have found that playing music:

- -Fights memory loss
- -Reduces stress
- -Lowers blood pressure
- -Staves off depression
- -Enhances cognitive development in children
- -Builds confidence
- -Creates social connections

In fact, 96% of public school principals believe that participating in music education encourages and motivates students to stay in school longer.

In addition, a new Harris Poll released in January 2008 of more than 2,000 people who don't currently play a musical instrument found that:

- -More than one in four (26%) people want to learn to play a musical instrument as their New Year's resolution in 2008
- -Almost half (47%) of the people who are interested in learning to play an instrument are finally starting to play
- -Nearly half (46%) of the respondents are likely or very likely to make "spending more time with family" and "reducing stress" their 2008 New Year's resolution
- -40% believe that playing an instrument reduces stress
- -35% say they believe they don't have natural talent to play and that prevents them from learning
- -23% responded that feeling too old has held them back from playing a musical instrument.

# EXCITEMENT BUILDS AS OPENING OF THE INTERNATIONAL YEAR OF THE ORGAN APPROACHES

NEW YORK CITY—The American Guild of Organists (AGO) has designated 2008– 2009 as the International Year of the Organ (IYO) and is partnering with organizations worldwide to celebrate the King of Instruments. The celebration will commence with the AGO National Convention in Minneapolis/St. Paul, Minn., June 22–26, 2008, and will conclude with the AGO Regional Conventions in the summer of 2009. #### AMERICAN GUILD OF ORGANISTS

The American Guild of Organists (AGO) will hold its 49th biennial National Convention in Minneapolis/St. Paul, Minn., June 22–26, 2008. More than 2,000 are expected to attend; more than 1,500 are already registered. Convention registration is open to all and will be headquartered at the Minneapolis Hilton Hotel. The 2008 AGO National Convention is the first to be held in the Twin Cities since 1980. Celebrating the "King of Instruments," the convention will include many inspiring performances of organ and choral music by internationally recognized artists and ensembles. More than 65 workshops on a variety of professional and interesting topics will be offered, including a Messiaen pedagogy track and choral reading sessions as well as 100 exhibits by organ builders, music publishers, and other vendors providing products of interest and services to the organ and choral music profession.

The International Year of the Organ (IYO), a year-long celebration of the organ, will be inaugurated at the AGO National Convention in the Twin Cities. The year will include various events designed to entertain, inform, and engage new audiences for organ music, while giving seasoned listeners a fresh perspective on the organ's expansive repertoire. The convention will feature the premier performances of works by Stephen Paulus of St. Paul, Minn., and Bernard

Wayne Sanders of Muehlheim, Germany, composed specifically for the IYO.

The AGO's prestigious national competitions in organ performance and improvisation will be conducted during the convention; each winner will be featured in recital. The winners of the AGO/Quimby Regional Competitions for Young Organists will be presented in nine "Rising Stars" recitals. The winning compositions of the AGO/ECS Publishing Award in Choral Composition and the AGO Award in Organ Composition will receive their premier performances. American Public Media's *Pipedreams Live* will be a highlight of the convention and will be recorded for future broadcast.

The world renowned Saint Paul Cathedral Choir, London, under the direction of Andrew Carwood, will be in residence for three days of the convention. The choir will give a full concert at the Saint Paul Cathedral in St. Paul, and will sing Choral Matins and Evensong at the Basilica of Saint Mary in Minneapolis. The choir's participation in the convention is made possible by a generous grant from the St. Paul Foundation, Katherine B. Andersen Fund.

The commissioning and the premier performances of 11 masterworks representing an hour of new music has garnered the support of the National Endowment for the Arts (NEA). Commissioned composers include Judith Bingham, Jaakko Mäntyjärvi, Aaron Kernis, Libby Larsen, and Steven Stucky. In addition, six short pieces for organ and orchestral instruments were commissioned for the *Little (Minnesota) Organ Book*, to be published by Augsburg Fortress Press. This collection will contain the commissioned works of Carol Barnett, Cary John Franklin, Linda Tutas Haugen, Monte Mason, David

Evan Thomas, and Janika Vandervelde.

#### **ASCAP**

ASCAP has had an excellent year so far in 2008, announcing record revenues and royalty payments as well as success in great initiatives in the protection of the rights of its members. ASCAP, now in its 94<sup>th</sup> year as a Performing Rights Organization, reported revenues for 2007 that exceeded the previous year's by \$77 million. Final revenues were a record-breaking \$863 million with distribution payments totaling \$741 million. Due to pioneering business strategies, the Society's operating costs reached an all-time low of 11.9%, the lowest in the world for a performing rights organization. ASCAP attributes its exceptional performance to five key factors: tirelessly building revenues from the licensing of existing and new music channels; consistently distributing more royalties to its members; aggressively implementing innovative technology; relentlessly managing operating costs; and tenaciously focusing on providing superior member benefits.

In addition, ASCAP also made huge strides in supporting education for children on the issue of illegal downloading of copyrighted music. In conjunction with i-SAFE, the leader in Internet safety education, ASCAP created the nation's first comprehensive educational program addressing why personal piracy of music and other creative content is harmful. Titled "The Donny the Downloader Experience," this new program is being presented in schools across the U.S.

Since its launch in February, the program, which was conceived to help encourage future music appreciators, has already reached nearly a million students through assemblies and an interactive curriculum.

To address the increasing concerns of its members, ASCAP also released a groundbreaking position paper "Music Copyright in the Digital Age," which outlines and explains the basic rights of music creators. As part of the same multitiered plan to protect the future rights of its members, the position paper contains an ASCAP-created Bill of Rights for Songwriters and Composers, which so far has collected over 6,000 signatures online. The Bill of Rights section acts as a reminder to all members of the music industry that the rights of songwriters need to be acknowledged and defended.

In April 2008, an historic decision was reached by the United States District Court for the Southern District of New York that determined a framework for reasonable license fees to be paid to ASCAP by AOL, RealNetworks, and Yahoo!. Rather than settle for a lesser amount, ASCAP fought for three years to guarantee just compensation for the use of its members' works. Based on the formula established by the Court, the total payments to be made for the period between July 1, 2002 and December 31, 2009 could reach \$100 million.

As further proof of ASCAP's dedication to enriching and educating its members, the third annual ASCAP "I Create Music" EXPO brought together the best and brightest songwriters, composers, producers and music industry members in Los Angeles for three days of packed panels, demonstrations and events from April 10-12, 2008. As the only conference devoted to the craft of songwriting and composing, the

### Ringback Tones Lead Mobile Music Market Growth in '08

BMI has released its annual mobile music market projections for 2008 and figures for 2007, projecting that ringback tones will surpass \$210 million in U.S. retail sales during calendar year 2008, up 50% from BMI's 2007 market estimate of \$140 million. A ringback tone is a musical work that is performed to callers when they place a call to a participating mobile subscriber. BMI also predicted that the U.S. ringtone market will continue to decline in 2008, generating approximately \$510 million in retail sales for the calendar year. ## Jazz Appreciation Month in Washington, D.C.

Composer Christopher Young will receive the Richard Kirk Award for outstanding career achievement at BMI's annual Film & Television Awards on Wednesday, May 21 in Los Angeles. Staged at the Beverly Wilshire Hotel, the black-tie, invitation-only dinner will also honor the composers of the past year's top-grossing films, top-rated prime-time network television series and highest-ranking cable network programs. Named in honor of former BMI Vice President and film & television department founder Richard Kirk, the Richard Kirk Award is bestowed on composers who have made significant contributions to film and television.

# Gustavo Santaolalla To Be Honored as Icon

Grammy and Oscar award-winning composer and producer Gustavo Santaolalla will be honored as an Icon on Thursday, June 12 at BMI's 15th annual Latin Awards. Staged at the Beverly Wilshire in Los Angeles, the black-tie, invitation-only gala will also recognize the songwriters and publishers of the past year's top BMI Latin songs played on American radio and television. The BMI Icon award is bestowed on creators who have had a "unique and indelible influence on generations of music makers." An all-star musical tribute will pay homage to the achievements of Gustavo Santaolalla.

### NAMM FOUNDATION NAMES THE 'BEST COMMUNITIES FOR MUSIC EDUCATION'

CARLSBAD, Calif. (April 29, 2008)—The NAMM Foundation today announced the results of the ninth annual "Best Communities for Music Education" survey, which includes 110 school districts across the U.S. The designated programs exemplify a community's commitment to include music education as part of a quality education for all children. The NAMM Foundation and its music education advocacy efforts work to ensure that all children have access to quality music education programs which encourage lifelong participation in music making.

This year's roster of schools represents 29 states, with New York, New Jersey, Ohio, Pennsylvania, Texas and Virginia representing the most districts. To view the complete roster of "Best Communities," visit <a href="https://www.nammfoundation.org">www.nammfoundation.org</a>.

Hundreds of teachers, school and district administrators, school board members, parents and community leaders, representing communities in all 50 states, participated in

the Web-based survey. The districts were measured across a variety of program support, curricular and programmatic criteria. The results were measured proportionally, so that communities of different sizes were compared equally.

Participants in the survey answered detailed questions about funding, enrollment, student/teacher ratios, music class participation, instruction time, facilities, support for the music program, private music lesson participation, and other relevant factors in their communities' music education programs. The responses were verified with district officials, and the sponsoring organizations reviewed the data.

"We commend these school districts for their commitment to assuring that music is part of a complete education for children," said Mary Luehrsen, executive director, NAMM Foundation. "It takes the commitment of an entire community to assure that music is part of the core curriculum. Children engaged in music will be the innovation leaders of tomorrow, and there is no better way to build life-long participation in music than with a solid base of music education."

Luehrsen also noted that throughout the survey's eight years several districts have reported that making the "Best Communities" list has had a tangible effect on their ability to preserve school music programs for their students. This year, recipients cited increased enrollment in music programs and more support from parents and community members as they realize the physical, mental and emotional enrichment music education brings to students.

Research reveals strong correlations between quality music education in school and academic achievement. Students actively involved with music programs develop skills needed by the 21st century workforce, including critical thinking, creative problem solving, effective communication and team work.
